Segment Two Layout

1. Prestige Driving School will provide a minimum of 6 hours of classroom instruction as required by the Michigan Department of State. These 6 hours of instruction shall not exceed 2 hours of instruction/day.
2. Successful completion of the course will meet previously mentioned class time requirements. In addition, the student will need to have all assignments turned in, maintain at least a C average with class material, and pass the state test with a score of 70% or better.
3. The 6 hours of classroom instruction will focus on the combination of previous instruction along with the recent driving experience with an adult. Students will have the opportunity to discuss successes and challenges on the Level 1 license. Course material will be driven by statistics, data, and research done by the State of Michigan.
4. Upon completion of the course, the student will be issued a certificate of completion, which would be exchanged (in due time) for a Level 2 license. This license would come after completion of the required timetables of age, time spent on a Level 1 license, and successful completion of a third party driving skills test.

Terms

1. The parent or guardian agrees to pay the non-refundable fee of \$85. The full payment is required by the first day of class. Payment must be received in advance to guarantee a spot in the class. There is a \$25 charge for all returned checks. Materials for class are provided. Replacement certificates will incur a \$20 charge. Fees can be paid in the form of cash or check.
2. The student must attend the three consecutive classes to complete the course. Failure to do so will mean starting over in a different offering of the course. Tuition that has already been paid can be transferred to the new course, but no refunds will be given if one elects to go elsewhere.
